## 43/20 Public Participation

Members acknowledged receipt of a letter regarding review of the Parish Plan in response to the government white paper on reform of the planning system.

Shropshire Cllr. Williams expressed the view that, given the time it takes to consult and move a white paper forward to future legislation, any changes to the planning regime are not imminent and it is doubtful that any changes will significantly affect rural areas or the classification of Loppington as open countryside.

It is the Governments ambition to bring forward more housing however the difficulty is that many developers have permission but are choosing not to build.

Shropshire Council is currently in the final consultation stages of the review of the Local Plan in which Loppington is classed as open countryside.

The level of fear as a result of the white paper is perhaps unfounded; irrespective of the white paper he acknowledged that a review of the Loppington Parish Plan is overdue.

A member of the Village Hall Committee thanked the Parish Council for their assistance in obtaining new storage sheds.
