The applicants' agent had offered to speak to the parish clerk with a view to parish clerk informing them (the Parish Council) with a view to receiving a "no objection" reply. The Parish Council took note of the applicants' submissions and indicated they had

no further objections. The Clerk informed the meeting that, having spoken with the LPA, this application is written up for a delegated decision to be issued either today or tomorrow and therefore the Parish Council, irrespective of its considerations, may not be able to submit further comments.

The pavement adjacent to the pond at Pickhill/A528 junction is cracked due to subsidence at the back of the footpath caused by regular flooding on this corner. Apparently the drain is blocked by tarmac which is causing the flooding damage and subsequently damage to the fencing around the pond.
