Spenford House requires significant repairs; the gable end is in poor state of repair & dangerous.

The existing garage will need a rebuild and is also needed for accommodation whilst repairs to the main house are being done.

The Applicant gave a broad explanation for the proposed alterations including the reason for the extended rear porch and proposed orangery.

A meeting had taken place between the Applicant and the Conservation Officer and the Applicant assured the Parish Council that various repairs and replacements have been informally agreed.

The extended driveway is required as the proposed new garage & studio needs to be a far back as possible in the site to mitigate the impact on the setting of the listed building and conservation area.

The Parish Council acknowledged that a meeting had taken place between the Applicant and the Conservation Officer, however the Parish Council are not party to any agreement or otherwise regarding the proposed repairs and alterations which makes it difficult for the Parish Council to form a detailed opinion. The Parish Council can only comment on the plans and documents available as submitted with the Application. Having examined the plans, the Parish Council noted a significant number of alterations to the listed building or its setting.

- neutral or beneficial, removal of the existing 20C conservatory,
- large orangery has a harmful impact on the listed building as it requires significant demolition of internal and external walls.
- large open plan living space is inappropriate both in scale and size and will result in unnecessary demolition and damage to the structure of the building changing the distinctive character of Spenford House.
- What appears to be unnecessary additional buildings & extensions. The
  Parish Council acknowledge the reason for the proposed conversion of the
  existing garage, however it is a substantial change to an ancillary building
  within the curtilage of a listed building providing sufficient facilities for
  independent living and forming a separate additional dwelling
- Members expressed reservations regarding the need to move the proposed access and development associated with this.
