2/24 Public Participation

Concerns were raised regarding the state of the side roads around the Parish. Roads identified by residents and members are Salters Lane and Commonwood. There is an excessive amount of mud on these roads exacerbated by the recent heavy rains.

Salters Lane is an ongoing problem, during heavy rainfall soil and silt is washed down from the higher land and verges either side onto the road.

At Commonwood concerns were raised with regard to slurry content which can carry the clostridium bacteria creating a health hazard to young people and walkers who regularly use the lanes.

Following discussions members noted the increasing disparity between statutory costs and the precept resulting in an increasing deficit in contingency reserves. To recover the deficit due to rapidly rising prices of the previous two years, members considered a 3-year plan to balance the reserves by increasing the precept by 20%, 15% and 10% but subject to annual review. RESOLVED: it was proposed, seconded and members agreed unanimously to increase the precept by 20% on last year's payment.

Members received the NJC Pay Award for Clerks from NALC. The pay award is a flat rate effectively increasing salaries by £1 hourly. RESOLVED:
