Comment: Members agreed that the Parish Council should object on basis that the proposed development is twice size and fully enclosed and therefore the design and scale is not in keeping with the building. It is desirable that any replacement porch is 'like for like' open canopy.

insertion of partition walls to new bathroom created, formation of new door from proposed bathroom into adjacent bedroom 3, removal of existing shower room and partitions and floor joists to new stair location and installation of new stairs.

Comment: Object - Members highlighted the discrepancies on the plans regarding bedroom numbers, and noted the wall to be removed at the foot of the new stairs and re-siting of the staircase requiring possible removal of historic fabric. Members noted the conservation officer comments but questioned the "original" position of the stairs. Members noted the repositioning of the bathroom in bed 2 FF-PR which the PC believe requires a new application, and raised concerns regarding the plumbing services which would likely be at the front of the property SW elevation.

Comment: Object to the size of orangery and design which is not in keeping, and significant removal of the historic fabric mainly ground floor walls to create new door openings and open plan living. New door opening onto balcony from beds 1 & 3 onto a modern balcony is not in keeping with the listed building.

The proposal has not changed since the previous application and the Parish Council wishes to maintain that objection which was also largely supported by the LPA Conservation team.
